BE IT HEREBY RESOLVED that Deer Path Lane at Beckett Ridge Boulevard, Union Township, Ohio, South for a distance of 425' is hereby designated a NO PARKING zone on both sides of the street.

This notice will be posted in five conspicuous places for a period of thirty days prior to the installation of the NO PARKING signs.


