Be It Resolved by the Township Trustees of Union Township, that

RESOLUTION ADOPTING CINCINNATI-COLUMBUS ROAD CORRIDOR LAND USE PLAN

Whereas, the Union Township Board of Trustees have identified the need for a Township Land Use Plan to guide the township in day to day development decisions; and

Whereas, the Board of Trustees, at a public hearing, on March 12, 1990, passed a Resolution creating the Union Township Land Use Planning Committee; and

Whereas, the purpose of said committee is to work with the Township staff to formulate goals and objectives for the Township Land Use Plan; and

Whereas, the Board of Trustees identified the need to establish administrative procedures for the adoption, implementation, and amendment of the Township Land Use Plan and said Board on May 28, 1991, passed a Resolution creating such procedures

Now Therefore Be It Resolved, that the Union Township Board of Trustees in accordance with the procedures set forth in Resolution 91-14 hereby adopt the Cincinnati-Columbus Road Corridor Land Use Plan, which is one of six components of the Union Township Land Use Plan.

Be It Further Resolved, that the purpose of this adoption is to:

- 1. Accommodate future needs,
2. provide for orderly growth,
3. provide the Trustees with a sound basis for making short-range decisions,
4. provide an official position that property owners can count on, and
5. achieve development coordination among adjacent interrelated sites.




