

**RESOLUTION NO. 15-2019**

**RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED  
BY THE BUTLER COUNTY BUDGET COMMISSION AND AUTHORIZING THE  
NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY  
AUDITOR AND DECLARING AN EMERGENCY AND DISPENSING WITH THE  
SECOND READING**

**WHEREAS**, the Board of Trustees of West Chester Township, Butler County, Ohio in accordance with statute has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2020; and,

**WHEREAS**, the Butler County Budget Commission has certified its action thereon to the Board, together with an estimate by the County Auditor to the rate of each tax necessary to be levied by this Board, and what part thereof is without, and what part within the ten mill tax limitation.

**NOW THEREFORE BE IT RESOLVED**, the West Chester Township Board of Trustees hereby agree to:

**SECTION 1.** Accept the amounts and rates as determined by the Budget Commission in its certification as set forth in Schedule A herein.

**SECTION 2.** Levy on the tax duplicate of West Chester Township, the rate of each tax necessary to be levied within and without the ten-mill limitation as listed below in Schedule B.

**This resolution shall be adopted as an emergency necessary for the immediate preservation of the public peace, health, safety, or welfare of the community and shall become effective at the earliest date permitted by law.**
