Case # MC01-22 - The Village North

Staff report: Mr. Tim Dawson presented the staff report, including a PowerPoint presentation, aerials, site history, as well as numerous staff concerns, considerations, and conditions. He also commented on the process for amending the plan to allow for a proposed drive-thru restaurant, if the Board deemed it an acceptable use. Mr. Dawson concluded by saying the Trustees were to either approve, approve with modifications, or deny the submitted Major Change. Mr. Dawson responded to questions from the Trustees.

Mr. Welch then invited the applicant to address the Board:

George Flynn with Flynn Property Group, 9378 Kemper Grove Lane, Loveland, said he was there that evening with his partner, Max Davis with Kraus Rhode Partners. He said they have purchased the subject property. He said they've arranged with the West Chester and Liberty Township Police and Fire Department to have training runs at the two buildings on the property because they want to be good neighbors. He compared his plan with the 2018 plan as presented to the Board, presenting data and identifying the plan improvements. Mr. Flynn said everything was going to be "high end", upscale, have significant walkability, and comparable to Savoy. He said he wanted the entire area designated a DORA.

Jose Casterjon, Vice President of Landscape Architecture & Planning with McGill, Smith & Punshon, 3700 Park 42 Drive, explained how the open space would become the glue to the development. He noted pedestrian safety features and livability. He responded to Trustee comments.

George Flynn returned and commented why they are seeking approval for a restaurant with a drive-thru, as well as several other aspects of his proposal. He and Mr. Casterjon commented on approximately \$3 million in improvements that the site requires, Butler County's interest in participating, and the potential for TIF funding.
