At 5:05 p.m., Mr. Wong motioned to recess the Regular meeting and go into Executive Session with legal counsel for the purpose of: (1) Considering confidential information related to the marketing plans, specific business strategy, production techniques, trade secrets, or personal financial statements of an applicant for economic development assistance, or to negotiations with other political subdivisions respecting requests for economic development assistance (provided both of the criteria specified in O.R.C. 121.22(G)(8); (2) Conference with an attorney for the Township concerning disputes involving the Township that are the subject of pending or imminent court action. O.R.C. 121.22(G)(3); (3) Preparing for, conducting, or reviewing negotiations or bargaining sessions with public employees concerning their compensation or other terms and conditions of their employment. O.R.C. 121.22(G)(4). Motion seconded by Mr. Welch. Mrs. Becker declared the meeting in recess and said the Board would return. Discussion: none. **Motion carried unanimously.**

**MOTION** made by Mr. Welch, seconded by Mr. Wong, to approve payment of requisitions 1 through 11. Discussion: Mr. Burks confirmed for Mr. Wong that 18 businesses were awarded grants, adding that they would be identified the next day. At Mrs. Becker's request, Fire Chief Prinz gave an update on his department's current and ongoing staffing. In response to Mr.

Welch's inquiry, Chief Prinz said they have 20 part-timer positions, of which they only have nine currently filled. He said the reason for hiring the part-timers was twofold: (1) so they could demonstrate their qualifications for being hired full-time, and (2) the part-timers would help reduce overtime pay. He said the new hires would attend West Chester Fire Academy from 8 to 4 daily for six weeks, as well as outside training. Mrs. Becker asked about the condition of the Administration Building parking lot. Services Director Hindupur explained the need for resurfacing the parking lot. **Motion carried unanimously.** 

### **Business Items**

**MOTION** made by Mr. Wong, seconded by Mr. Welch, to approve 2023 financial contribution to the National Voice of America Museum of Broadcasting in the amount of \$50,000.00. Discussion: Mr. Wong began a discussion as to the continued contribution to the museum. **Motion carried unanimously.** 

MOTION made by Mr. Welch, seconded by Mr. Wong, on the agenda item to approve 2023 Gold Sustaining Sponsorship of \$10,000.00 to the West Chester Liberty Chamber Alliance; and, authorize Township Administrator to sign Memorandum of Understanding setting the terms for the investment, was tabled in a MOTION to table the item until the next meeting; motion made by Mr. Wong and seconded by Mrs. Becker. Discussion: Prior to the motion to table, Mr. Wong said the Township should contribute to all chambers equally, and critiqued the West Chester/Liberty Chamber for not recognizing him and other elected officials individually at Chamber functions. Mr. Welch questioned what the different Chambers did for West Chester. Motion carried unanimously.

**MOTION** made by Mr. Welch, seconded by Mr. Wong, to approve Resolution 15-2023 and amend Lease and Joint Operation of Range Agreement between West Chester Township Board of Trustees and Butler County Board of County Commissioners. Discussion: none. **Motion carried unanimously.** 

**MOTION** made by Mr. Wong, seconded by Mr. Welch, to not object to a New D5 liquor permit for My Lotus Events LLC 9145 Cincinnati Columbus Road. Discussion: none. **Motion carried unanimously.** 

**MOTION** made by Mr. Welch, seconded by Mr. Wong, to not object to a TRFO D5 and D6 liquor permit from MetroParks of Butler County & Patio, 7850 VOA Park Drive, to Abner Property Management LLC, The Lodge & Patio, 7850 VOA Park Drive. Discussion: Mrs. Becker noted that this was a for-profit entity at the VOA MetroPark. **Motion carried unanimously.**

We're a melting pot where we assimilate, adding that's how you get to know your neighbors. Mr. Wong added that Chinese were once oppressed in the United States.

Mr. Burks noted that West Chester was recognized by the Ohio City County Managers Association for career development and mentoring with our staff. On April 6<sup>th</sup> they will have the awards ceremony.
