MOTION made by Mrs. Becker, seconded by Mr. Welch, to amend the agenda so as to move Personnel Items 4 through 8 to immediately after Citizens Comments. Discussion: none. **Motion carried unanimously.**

At 5:02 p.m., Mr. Wong motioned to recess the Regular meeting and go into Executive Session with legal counsel for the purpose of: (1) Conferencing with an attorney for the Township concerning disputes involving the Township that are the subject of pending or imminent court action. O.R.C. 121.22(G)(3); (2) to consider the purchase of property for public purposes, the sale of property by competitive bid, or the sale or other disposition of unneeded, obsolete, or unfit-for-use property in accordance with section 505.10 of the Revised Code. O.R.C. 121.22(G)(2). Motion seconded by Mr. Welch. Mr. Becker said the Board would return to adjourn the Executive Session and to resume the Regular meeting. Discussion: none. **Motion carried unanimously.** Mrs. Becker declared the meeting in recess.

Citizen's Comments

Amy Raghuraman, 9705 Timberview Court, expressed her concerns about the small business grants recently given by the township. She was displeased that grants were given outside of the Pisgah/Route 42 area as originally discussed, and that grants were given to established businesses that didn't need the money for improvements. She heard that a second round of grants would be issued and asked that those grants be given to "up and coming" businesses or those with aging infrastructures. She also suggested that the township have a "center" to help businesses.

Discussion Items & Elected Official Comments

Mrs. Becker responded to the comment from Amy Raghuraman during Citizen Comments, saying grants were awarded based on a scoring system, the Trustees had nothing to do with the scoring, and she would be happy to share the scoring system with her. Mrs. Becker also recognized the upcoming Memorial Day parade and remembrance, and the bicentennial celebrations the following weekend.

Mr. Welch "put in a plug" for the dunking booth at Sozo Hair that Saturday, noting recognizable people to be dunked, with contributions benefiting the Historical Society.

Mr. Wong recognized the shooting death of a Kentucky police officer at the hands of an assailant that had been linked to recent robberies in West Chester. He encouraged our residents to secure our property from theft. Police Chief Herzog said his department would be recognizing the officer at his funeral.

Mr. Jones thanked Mr. Wong for his account of the police officer's death. He also noted the closure of Tylersville Road at the Freshman school for the construction of a roundabout beginning May 30th. Lastly, he expressed his appreciation for those who gave their all for our freedom, and encourage people to being their children to the parade and ceremony at Brookside Cemetery.
