# Record of Proceedings: June 13, 2023 West Chester Township Board of Trustees - Regular Meeting

Convene: Chairperson Becker convened the meeting at 6:00 p.m. Roll Call: Mrs. Becker, Mr. Wong, and Mr. Welch responded.

Pledge of Allegiance: Repeated by those present.

**MOTION** made by Mrs. Becker, seconded by Mr. Welch, to amend the agenda so as to move Personnel Items 6 through 8 to immediately after Citizens Comments. Discussion: none. **Motion carried unanimously.** 

#### Citizen's Comments

Mary Jo Bucknell, 5171 Rialto Road, thanked the Board for its support of the bicentennial. In response to a question from the Board, she said the West Chester Historical Center is available for tours by inspection.

# Personnel Items

Mr. Burks introduced the Personnel Items consisting of, (1) Hire Bryan Hellard to the position of Property Advisor effective June 5, 2023 at the hourly rate of \$26.00; (2) Police Hire Alexander Fillios to the position of Police Officer effective August 14, 2023 at the bi-weekly rate of \$2,622.19; (3). Services Hire Nathaniel Staton to the position of Laborer Operator effective June 5, 2023 at the hourly rate of \$19.94. These were identified on the agenda as Personnel Items 6, 7, and 8 respectively.

MOTION made by Mr. Welch, seconded by Mr. Wong, to recommend terms of Enterprise Zone Agreement of 60% abatement for a seven-year term with 4R Investments, dba Republic Wire LLC. Discussion: Mr. Welch recognized Ron and Jeremy Rosenbeck, Republic Wire principals, in the audience, and praised them for their entrepreneurship. Ron expressed his appreciation for West Chester. Community Development Director Aaron Wiegand addressed the Board, noting an abatement would also need approval by Butler County Commissioners and the Lakota School Board. He also said the township has granted very few abatements and the township was already a low tax environment. Motion carried unanimously.

Staff report: Mr. Tim Dawson presented the staff report with a PowerPoint presentation, aerials, site history, proposed development as well as staff considerations and comments. Mr. Dawson concluded by saying the Trustees were to either approve the application, approve with modifications, or deny the submitted Zoning Map Amendment and Preliminary Development Plan.

Michael Copfer, Vice President of Land Acquisitions for Hills Properties, 4901 Hunt Road, Blue Ash, Ohio, addressed the Board. He compared the proposed development to what Hills Properties has already developed in West Chester. He also observed the difference between the current plan and the plan that had previously been approved. Mr. Copfer also noted numerous amenities with overviews/renderings and features in their proposal, as well as open space and parking compliance considerations. Mr. Copfer then responded to Trustee questions.
