# Record of Proceedings: January 23, 2024 West Chester Township Board of Trustees - Regular Meeting

Convene: Chairperson Wong convened the meeting at 5:02 p.m. Roll Call: Mr. Wong, Mr. Welch, and Mrs. Becker responded.

At 5:03 p.m., Mr. Wong motioned to recess the Regular meeting and go into Executive Session with legal counsel for the purpose of: (1) Considering dismissal or discipline of a public employee or official. O.R.C. 121.22(G)(1); (2) considering confidential information related to the marketing plans, specific business strategy, production techniques, trade secrets, or personal financial statements of an applicant for economic development assistance or negotiating with other political subdivisions respecting requests for economic development assistance. The information to be discussed is directly related to a request for economic development assistance that is to be provided under any of the Revised Code provisions set forth in O.R.C. 121.22(G)(8)(a), or involves public infrastructure improvements or the extension of utility services that are directly related to an economic development project.
