Emergency Resolution adopting and certifying the Township 2023 Permanent Appropriations and authorizing the transfer of funds from the General Fund to the Road and Bridge Fund and to the Cemetery Fund; advance out from the General Fund into the Coronavirus Relief Fund and declaring an emergency and dispensing with the second reading
