

**STATUTORY RESOLUTION NO. 15- 2012**

**RESOLUTION AUTHORIZING THE ESTABLISHMENT OF  
“NO PARKING ZONES” ON PORTIONS OF  
MANOR DRIVE, MINUTEMAN WAY, AND SMITH ROAD**

**WHEREAS**, the West Chester Township Board of Trustees is authorized by Ohio Revised Code §§ 505.17(A) and 4511.07 to regulate vehicle parking within the unincorporated area of the Township; and,

**WHEREAS**, Ohio Revised Code § 4511.07(1) allows further restriction to regulate the parking, standing or stopping of vehicles; and,

**WHEREAS**, it has been determined vehicle parking, standing, or stopping on portions of Manor Drive, Minuteman Way and Smith Road is a hazard to and creates conflicts for, between, and among vehicle, bicycle, and pedestrian traffic; and,

**WHEREAS**, West Chester Township Board of Trustees has determined regulation of no parking, standing, or stopping of vehicles on portions of Manor Drive, Minuteman Way, and Smith Road is necessary to preserve the health, safety and welfare of Township residents and commuters and no parking zones, restricting parking, standing, or stopping of vehicles should be established at the following locations:

Hopewell Elementary and Hopewell Junior Schools (Exhibit A) – Regulation of no parking, standing, or stopping of vehicles on Manor Drive on the north side between Candlelight Terrace and Rickhaven Court and on the south side between the west property line of 7849 Manor Drive and the east property line of 7879 Manor Drive school days between 7:00 – 9:00 a.m. and 2:00 – 4:00 p.m.; and,

Adena Elementary School (Exhibit B) – Regulation of no parking, standing, or stopping of vehicles on Minuteman Way in the school zone between Heritage Drive and Adena Hills Court school days between the hours of 8:00 – 9:00 a.m. and 2:30 – 3:30 pm; and,

Endeavor Elementary School (Exhibit C) – Regulation of no parking, standing, or stopping of vehicles on Smith Road in the school zone anytime school days between the hours of 8:00 – 9:00 a.m. and 2:30 – 3:30 p.m. and additionally, notwithstanding any existing regulatory traffic signage, no parking, standing, or stopping anytime on R.E. Smith Drive between Smith Road and Misty Shore Drive, and no parking, standing, or stopping anytime on Bar Harbor Way between Smith Road and South Port Drive; and,

**WHEREAS**, notice of these proposed “No Parking Zones,” restricting parking, standing, or stopping of vehicles has been posted in conspicuous places along the affected streets, and property owners have been notified accordingly; and,

**WHEREAS**, notice has been published in a newspaper of general circulation in the Township; and,

**WHEREAS**, on September 25, 2012, during one of its regularly scheduled meetings, the West Chester Township Board of Trustees conducted a public hearing where any interested or concerned citizen could attend and voice his opinion on the subject proposed no parking zones, restricting no parking, standing, or stopping.

**NOW, THEREFORE, BE IT RESOLVED** the West Chester Township Board of Trustees does hereby agree to:

**SECTION 1.** Establish on Manor Drive a no parking zone, restricting parking, standing, or stopping of vehicles on the north side of Manor Drive between Candlelight Terrace and Rickhaven Court and on the south side of Manor Drive between the west property line of 7849 Manor Drive and the east property line of 7879 Manor Drive school days between 7:00 – 9:00 a.m. and 2:00 – 4:00 p.m., effective thirty (30) days from the date this Resolution is approved and signed.

**SECTION 2.** Establish on Minuteman Way a no parking zone, restricting parking, standing, or stopping of vehicles on Minuteman Way in the school zone between Heritage Drive and Adena Hills Court school days between the hours of 8:00 – 9:00 a.m. and 2:30-3:30 p.m., effective thirty (30) days from the date this Resolution is approved and signed.

**SECTION 3.** Establish on Smith Road a no parking zone, restricting parking, standing, or stopping of vehicles on Smith Road in the school zone anytime school days between the hours of 8:00 – 9:00 a.m. and 2:30 – 3:30 p.m. and additionally, notwithstanding any existing regulatory traffic signage, no parking, standing, or stopping anytime on R.E. Smith Drive between Smith Road and Misty Shore Drive, and no parking, standing, or stopping anytime on Bar Harbor Way between Smith Road and South Port Drive, effective thirty (30) days from the date this Resolution is approved and signed.

**SECTION 4.** Post for thirty (30) days prior to the effective date of enforcement notice of these proposed “No Parking Zones,” restricting parking, standing, or stopping of vehicles in five conspicuous public places in the Township:

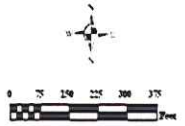
- a. West Chester Police Department – 9577 Beckett Road, Suite 500
- b. Midpointe West Chester Library – 9363 Centre Pointe Drive
- c. West Chester Activity Center – 7900 Cox Road
- d. West Chester Administration Building – 9113 Cincinnati-Dayton Road
- e. MetroParks Ronald Reagan Lodge at Voice of America Park – 7850 VOA Park Drive

**SECTION 5.** Determine any violation of these parking, standing, or stopping regulations for the “No Parking Zones” constitutes a minor misdemeanor; and,

**SECTION 6.** Authorize the Board or its designated agent, the West Chester Police Department, to order into storage any vehicle in violation of this Resolution.

- ◆ Proposed Sign Location



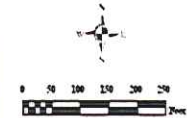
