STATUTORY RESOLUTION NO. 27 - 2014

RESOLUTION RATIFYING AMENDMENTS TO THE BUTLER COUNTY SOLID WASTE MANAGEMENT PLAN RECOMMENDED BY THE BUTLER COUNTY RECYCLING AND SOLID WASTE DISTRICT TO REVISE THE SOLID WASTE GENERATION FEE AND TO AMEND SECTION VIII OF THE SOLID WASTE MANAGEMENT PLAN OF BUTLER COUNTY, OHIO

WHEREAS, West Chester Township is located within the jurisdiction of Butler County Recycling and Solid Waste District (District) and;

WHEREAS, Butler County Recycling and Solid Waste District (District) Policy Committee prepared and adopted a resolution decreasing the generation fee from \$1.00 to \$0.82 for every ton of solid waste generated within Butler County in accordance with Ohio Revised Code Section 3734.56 and;

WHEREAS, the District Policy Committee amended Section VIII of the current solid waste management plan for Butler County to include the budgetary changes that resulted from the decrease in generation fee revenue and;

WHEREAS, the District has provided a copy of the resolution and associated budgetary changes in Section VIII of the current approved solid waste plan for ratification to each of the legislative authorities of the District and;

WHEREAS, the West Chester Board of Trustees must decide whether it approves of said resolution and amended Solid Waste Plan within sixty days of receipt of the resolution and amended Solid Waste Plan.

NOW THEREFORE, BE IT RESOLVED the West Chester Township Board of Trustees does hereby agree to:

SECTION 1. Ratify the amendments to the solid waste plan

SECTION 2. Send the District a copy of this resolution to the attention of Ms. Anne Fiehrer Flaig, District Coordinator, Butler County Recycling and Solid Waste District, 130 High Street, Hamilton, Ohio 45011

SECTION 3. Find and determine that all formal actions of this West Chester Township Board of Trustees concerning and relating to the passage of this resolution were adopted in an open meeting of this West Chester Township Board of Trustees and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Sections 121.22 of the Ohio Revised Code.
