## STATUTORY RESOLUTION NO. 22 - 2011

## RESOLUTION APPROVING THE SOLID WASTE MANAGEMENT PLAN UPDATE OF THE BUTLER COUNTY SOLID WASTE DISTRICT

WHEREAS, pursuant to the provisions of Chapter 3734, Ohio Revised Code (the "Act"), the Butler County Solid Waste Management District Policy Committee (the "Policy Committee") has adopted the Butler County Solid Waste Management Plan Update (the "Plan") for the Butler County Solid Waste Management District (the "District"); and,

WHEREAS, pursuant to the Act, all political subdivisions within the District must approve or disapprove the proposed Plan by ordinance or resolution by October 26, 2011; and,

WHEREAS, successful ratification requires approval of the proposed Solid Waste Management Plan Update by political subdivisions representing at least 60% of the District's population; and,

WHEREAS, the District has provided a copy of the Draft Solid Waste Management Plan Update for ratification to each of the legislative authorities of the District; and,

WHEREAS, the West Chester Township Board of Trustees must decide whether it approves of said Solid Waste Management Plan Update within ninety days of receipt of the Final Draft Plan; and,

WHEREAS, the West Chester Township Board of Trustees has reviewed and supports the Plan to manage, collect, and dispose of solid waste within Butler County.

**NOW, THEREFORE BE IT RESOLVED** that the West Chester Township Board of Trustees does hereby:

- **SECTION 1.** Approve the Butler County Solid Waste Management Plan Update, conditionally that if used, the West Chester Community Development Department shall approve the location and screening materials of any recycling drop boxes.
- **SECTION 2.** Declare that a true and correct copy of which was provided to the office of said Township Trustees together with revisions to the adopted Plan.
- **SECTION 3.** Authorize and direct the Fiscal Officer of West Chester Township to certify a copy of this Resolution to the Butler County Solid Waste District.
- **SECTION 4.** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
