STATUTORY RESOLUTION NO. 28-2010

RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A "NO PARKING ZONE" ALONG BOTH SIDES OF EAGLERIDGE DRIVE STARTING AT THE INTERSECTION OF LAKOTA DRIVE WEST TO THE PROPERTY LINE BETWEEN 8851 AND 8861 EAGLERIDGE DRIVE AND EQUAL DISTANCE ON THE EAST SIDE OF EAGLERIDGE DRIVE

WHEREAS, West Chester Township Trustees are empowered by Ohio Revised Code §§ 505.17(A) and 4511.07(A) to regulate vehicle parking within the unincorporated area of the Township; and,

WHEREAS, the West Chester Township Police Department has determined that vehicle parking along both sides of Eagleridge Drive starting at the intersection of Lakota Drive West to the property line between 8851 and 8861 Eagleridge Drive and equal distance on the east side of Eagleridge Drive has become a hazard to vehicle, bike and pedestrian traffic; and,

WHEREAS, West Chester Township Trustees agree with police officials a "No Parking Zone" at the aforesaid location is appropriate and necessary to preserve the health, safety and welfare of Township residents; and,

WHEREAS, notice of this proposed "No Parking Zone" has been posted in conspicuous places along the affected street, and property owners have been notified accordingly; and,

WHEREAS, notice has been duly published in a newspaper of general circulation in the Township.

NOW, THEREFORE, BE IT RESOLVED that the West Chester Township Board of Trustees hereby agrees to:

SECTION 1. Establish a "No Parking Zone" along both sides of Eagleridge Drive starting at the intersection of Lakota Drive West to the property line between 8851 and 8861 Eagleridge Drive and equal distance on the east side of Eagleridge Drive, effective thirty (30) days from the date this Resolution is approved and signed.

SECTION 2. Post for thirty (30) days prior to the effective date of enforcement, notice of this proposed "No Parking Zone" in five conspicuous public places in the Township:

- a. Township Police Department, 9577 Beckett Road
- b. West Chester Public Library, 9363 Centre Pointe Drive
- c. West Chester Activity Center, 7900 Cox Road
- d. West Chester Post Office, 8730 Cincinnati-Dayton Road
- e. Township Administration Building, 9113 Cincinnati-Dayton Road

SECTION 3. Determine that any violation of this "No Parking Zone" regulation constitutes a minor misdemeanor.

SECTION 4. Authorize the Board or its designated agent to order into storage any vehicle parked in violation of this parking regulation.
