
**WHEREAS**, the West Chester Township Board of Trustees finds it necessary to adopt Resolution 30-2010 for temporary appropriations for year 2011.

**NOW THEREFORE, BE IT RESOLVED** that the West Chester Township Board of Trustees does hereby agree to:




