RESOLUTION AUTHORIZING THE ESTABLISHMENT OF CAPITAL PROJECT FUNDS ENTITLED "SCOTT STREET/DUKE REALTY PROJECT FUND", "CINCINNATI-DAYTON AND WEST CHESTER ROADS INTERSECTION FUND" AND "BECKETT ROAD PROJECT FUND" AND AUTHORIZING THE TOWNSHIP FISCAL OFFICER TO AMEND THE TOWNSHIP 2008 APPROPRIATIONS AND TO REQUEST THE BUTLER COUNTY BUDGET COMMISSION TO AMEND THE WEST CHESTER TOWNSHIP CERTIFICATE OF ESTIMATED RESOURCES FOR BUDGET YEAR 2008

WHEREAS, on November 13, 2007 the Board of Trustees approved a service agreement between West Chester Township, Scott Street Partners-XLLC and Duke Realty Ohio for the use of tax increment financing for public improvements; and,

WHEREAS, on February 26, 2008 the Board of Trustees passed a) Resolution 06-2008 authorizing the issuance and sale of not to exceed \$1,655,000 road improvement bonds (Beckett Road Project) and b) Resolution 07-2008 authorizing the issuance and sale of not to exceed \$1,530,000 road improvement bonds (Cincinnati-Dayton and West Chester Roads Intersection); and,

WHEREAS, the Board of Trustees finds it necessary to amend the Township 2008 Appropriations to cover expenditures that were subsequently not reflected in the Township 2008 Appropriations; and,

WHEREAS, the Butler County Budget Commission must allow the Township Fiscal Officer to appropriate the necessary amounts for all Township funds.

**NOW THEREFORE BE IT RESOLVED,** that the West Chester Township Board of Trustees does hereby agree to:

**SECTION 1.** Authorize the Township Fiscal Officer to establish capital project funds entitled "SCOTT STREET/DUKE REALTY PROJECT FUND", "CINCINNATI-DAYTON AND WEST CHESTER ROADS INTERSECTION FUND", and "BECKETT ROAD PROJECT FUND".

**SECTION 2.** Authorize the Township Fiscal Officer to amend the 2008 Appropriations as follows.
