RESOLUTION AUTHORIZING THE SALE OF A 1993 ALAMO BATWING MOWER TO BUTLER COUNTY METROPARKS AND AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO EXECUTE ALL DOCUMENTS NECESSARY TO ACCOMPLISH THE TRANSFER

WHEREAS, the Ohio General Assembly amended Ohio Revised Code, Section 505.10 and enacted procedures for Townships to dispose of motor vehicles, road machinery, equipment and tools which are not needed, obsolete, or are unfit for public use; and,

WHEREAS, the Township Parks Department has placed a 1993 Alamo Batwing Mower, Model AGGK, 30 horsepower, serial number 01024 (the "Mower") on the disposal list as the equipment is no longer needed; and,

WHEREAS, Southeastern Equipment Company, Inc. recently appraised the Mower at \$2,400.00; and,

WHEREAS, when the value of said item is two thousand five hundred dollars (\$2,500.00) or less, the Board may sell the property by private sale without advertisement or public notification; and,

WHEREAS, Butler County MetroParks expressed interest in acquiring the Mower to use at Voice of America Park.

NOW THEREFORE, BE IT RESOLVED that, pursuant to Ohio Revised Code § 505.101, the West Chester Township Board of Trustees does hereby agree to:

SECTION 1. Authorize transfer of the Mower to Butler County MetroParks for \$1.00.

SECTION 2. Authorize the Township Administrator to execute documents and take such other actions as may be necessary to carry out this Resolution.
