

RESOLUTION NO. 19 - 2008

RESOLUTION AUTHORIZING THE TOWNSHIP FISCAL OFFICER TO AMEND THE TOWNSHIP 2008 APPROPRIATIONS AND TO REQUEST THE BUTLER COUNTY BUDGET COMMISSION TO AMEND THE WEST CHESTER TOWNSHIP CERTIFICATE OF ESTIMATED RESOURCES FOR BUDGET YEAR 2008 AND TO TRANSFER FUNDS FROM THE GENERAL FUND TO THE CEMETERY FUND AND FROM THE DUI TASK FORCE FUND TO THE POLICE FUND

WHEREAS, the Board of Trustees finds it necessary to amend the Township 2008 Appropriations for the Cemetery, Chappco TIF project, and West Chester 75 TIF project to cover expenditures that were subsequently not reflected in the Township 2008 Appropriations; and,

WHEREAS, the Butler County Budget Commission must allow the Township Fiscal Officer to appropriate the necessary amounts for all Township funds; and,

WHEREAS, the Board of Trustees finds it necessary to approve the transfers outlined below.

NOW THEREFORE BE IT RESOLVED, that the West Chester Township Board of Trustees does hereby agree to:

SECTION 1. Authorize the Township Fiscal Officer to amend the 2008 Appropriations as follows:
