RESOLUTION AUTHORIZING THE TOWNSHIP FISCAL OFFICER TO AMEND THE TOWNSHIP 2008 APPROPRIATIONS AND TO REQUEST THE BUTLER COUNTY BUDGET COMMISSION TO AMEND THE WEST CHESTER TOWNSHIP CERTIFICATE OF ESTIMATED RESOURCES FOR BUDGET YEAR 2008 AND AUTHORIZING THE TOWNSHIP FISCAL OFFICER TO TRANSFER FUNDS FROM THE POLICE FUND TO THE BULLET PROOF VEST FUND; FROM THE ASSISTANCE TO FIREFIGHTERS FUND TO THE FIRE DISTRICT FUND; FROM THE HIGHWAY SAFETY GRANT FUND TO THE POLICE DISTRICT FUND; AND FROM THE IKEA ROAD IMPROVEMENT FUND TO THE IKEA ROAD IMPROVEMENT DEBT SERVICE FUND
