

RESOLUTION NO. 32 - 2008

**RESOLUTION AUTHORIZING THE ADOPTION OF
TEMPORARY APPROPRIATIONS FOR YEAR 2009 AND DECLARING AN
EMERGENCY AND DISPENSING WITH THE SECOND READING**

WHEREAS, the Board of Township Trustees is required to pass a temporary or permanent Appropriations resolution for year 2009 on or before January 1, 2009; and,


