RESOLUTION NO. 09 - 2007

RESOLUTION AUTHORIZING THE ISSUANCE AND SALE OF NOT TO EXCEED \$7,050,000 VARIOUS PURPOSE BONDS, SERIES 2007 AND DECLARING AN EMERGENCY AND DISPENSING WITH THE SECOND READING

WHEREAS, this Board of Trustee (the "Board") of West Chester Township, Ohio (the "County") has previously passed three separate bond resolutions numbered <u>06-2007</u>, <u>07-2007</u>, and <u>08-2007</u> inclusive (the "Bond Resolutions"), which such resolutions authorized seven separate bond issues of the Township (collectively, "the Bonds"), to pay the cost of (1) engineering and construction of certain road improvements for the further development of the IKEA site and the adjoining corners of the intersection, (2) engineering and construction of certain road improvements for the Union Centre Boulevard (UCB) and Muhlhauser Road intersection and ancillary improvements to adjoining roadways, including West Chester Road, Allen Road, and Cincinnati-Dayton Road, and (3) architectural, engineering, and professional services and potentially preliminary construction costs for the fire headquarters and station 1, the communications center, and ancillary improvements to the campus, and the pay costs of issuance of the bonds; and,

WHEREAS, this Board desires to consolidate the three issues into a single issue to achieve certain costs savings;

- **NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of West Chester Township, County of Butler, Ohio, all members elected thereto concurring:
- **SECTION 1.** That, pursuant to the provisions of Section 133.03, O.R.C., the three separate issues of the Bonds shall be consolidated into a single issue of the Township's bonds which shall be known as "Various Purpose Bonds, Series 2007" (the "Consolidated Bonds").
- **SECTION 2.** That the Consolidated Bonds shall bear interest at such rates, and have maturities or principal payments consistent with the interest rates on and the aggregate of the periodic maturities or principal payments of the Bonds.
- **SECTION 3.** That the proceeds of the sale of the Consolidated Bonds shall be apportioned, deposited and credited in accordance with the amount of each of the issues of the Consolidated Bonds authorized by the Bond Resolutions.
- **SECTION 4.** That it is found and determined that all formal actions of this Board of Trustees concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board; and that all deliberations of this Board of Trustees and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law.
- **SECTION 5.** The Fiscal Officer of this Board is hereby directed to forward a copy of this resolution to the County Auditor.

This resolution shall be adopted as an emergency necessary for the immediate preservation of the public peace, health, safety, or welfare of the community and shall become effective at the earliest date permitted by law.
