**RESOLUTION REQUESTING A REVIEW OF THE SPEED LIMIT ENGINEERING AND TRAFFIC INVESTIGATION STUDY FOR LESOURDSVILLE-WEST CHESTER ROAD BETWEEN TYLERSVILLE AND HAMILTON-MASON ROADS AND DETERMINE THAT THE STATUTORY VEHICULAR SPEED LIMIT ESTABLISHED BY SECTION 4511.21, REVISED CODE OF OHIO IS GREATER (OR LESS) THAN THAT CONSIDERED REASONABLE AND SAFE**

**WHEREAS**, it needs to be determined that the statutory vehicular speed limit, established by Section 4511.21, Revised Code of Ohio for Lesourdsville-West Chester Road between Tylersville Road and Hamilton-Mason Road, is greater (or less) than that considered reasonable and safe; and,

**WHEREAS**, The Board of Township Trustees desires the Butler County Engineer's Office (BCEO), on behalf of the Board, to request the Ohio Department of Transportation to review engineering and traffic investigation studies to determine that the speed permitted is reasonable and safe for the conditions found to exist at the subject section of Lesourdsville-West Chester Road; and,


**WHEREAS**, it is the belief of the Board of Trustees that such investigation will confirm the allegation that the statutory speed limit of 45 mph is unrealistic.

**NOW THEREFORE, BE IT RESOLVED** that the West Chester Township Board of Trustees does hereby agree to:


**SECTION 1.** Request, pursuant to the provisions of Section 4511.21, Revised Code of Ohio, the Director of Ohio Highways to review the engineering and traffic investigation and to determine and declare a reasonable and safe prima facie speed limit on Lesourdsville-West Chester Road between Tylersville Road and Hamilton-Mason Road in Butler County, Ohio.

**SECTION 2.** Authorize, once the Director of Ohio Highways has determined and declared a reasonable and safe speed limit on the section of road described in Section 1 hereof, the properly posting of and giving notice thereof that standard signs will be erected.


