## RESOLUTION AUTHORIZING ESTABLISHMENT OF A SPECIAL REVENUE FUND ENTITLED "UCB LANDSCAPE MAINTENANCE DISTRICT FUND"

WHEREAS, on August 10, 2004, the West Chester Township Board of Trustees declared the necessity for and created the Union Centre Road District – Interchange and Boulevard Landscape Improvement and Maintenance in order to maintain the landscape and beautification improvements and to preserve the economic vitality and marketability of Union Centre for the public convenience and welfare; authorized an apportionment to be applied to affected real estate; and authorize the Clerk to certify said assessment for applicable real estate to the Butler County Auditor pursuant to ORC §5573.11; and,

**WHEREAS**, the West Chester Township Board of Trustees has determined it necessary to account for the revenue and expenditures generated by the Union Centre Boulevard Landscape Maintenance District as outlined in Resolution No. 47-2004; and,

WHEREAS, the Board of Trustees has determined that the current fund structure does not account for nor provide all relevant information for the UCB Landscape Maintenance District operations; and,

**WHEREAS**, the Ohio Revised Code Section 5705.12 permits, by Resolution, Township Trustees to create new funds; and,

WHEREAS, the Board of Trustees determines it necessary to create a new fund to account for and to provide all relevant information for the UCB Landscape Maintenance District operations.

**NOW THEREFORE BE IT RESOLVED**, that the West Chester Township Board of Trustees does hereby agree to:

**SECTION 1.** Authorize the Township Clerk/Treasurer to establish a special revenue fund entitled "UCB Landscape Maintenance District Fund" to account for all UCB Landscape Maintenance District operations.
