RESOLUTION NO. 27 - 2005

RESOLUTION APPROVING THE SOLID WASTE MANAGEMENT PLAN OF THE BUTLER COUNTY SOLID WASTE DISTRICT; AND DECLARING AN EMERGENCY AND DISPENSING WITH THE SECOND READING

WHEREAS, pursuant to the provisions of Chapter 3734, Ohio Revised Code (the "Act"), the Butler County Solid Waste Management Policy Committee (the "Policy Committee") has adopted the Butler County Solid Waste Management Plan Update (the "Plan") for the Butler County Solid Waste Management District (the "District"); and,

WHEREAS, pursuant to the Act, all political subdivisions within the District must approve or disapprove the proposed Plan by ordinance or resolution by August 15, 2005; and,

WHEREAS, successful ratification requires approval of the proposed Solid Waste Management Plan by political subdivisions representing at least 60% of the District's population; and,

WHEREAS, the West Chester Township Board of Trustees has reviewed and supports the Plan to manage, collect, and dispose of solid waste within Butler County.

NOW, THEREFORE BE IT RESOLVED that the West Chester Township Board of Trustees does hereby:

- **SECTION 1.** Approve the Butler County Solid Waste Management Plan Update, conditionally that if used, the West Chester Planning and Zoning Department shall approve the location and screening materials of any recycling drop boxes.
- **SECTION 2.** Declare that a true and correct copy of which was provided to the office of said township trustees together with revisions to the adopted Plan.
- **SECTION 3.** Authorize and direct the Clerk of West Chester Township to certify copies of this resolution to the Butler County Solid Waste District.
- **SECTION 4.** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

This resolution shall be adopted as an emergency necessary for the immediate preservation of the public peace, health, safety, or welfare of the community and shall become effective at the earliest date permitted by law.
