

RESOLUTION NO. 32 - 2005

**RESOLUTION AUTHORIZING THE TOWNSHIP CLERK TO
AMEND THE TOWNSHIP 2005 APPROPRIATIONS AND TO
REQUEST THE BUTLER COUNTY BUDGET COMMISSION TO
AMEND THE WEST CHESTER TOWNSHIP CERTIFICATE OF
ESTIMATED RESOURCES FOR BUDGET YEAR 2005**

WHEREAS, the West Chester Township 2005 Appropriations were approved by the Board of Trustees on December 21, 2004 and certified to the Butler County Budget Commission; and,

WHEREAS, the Board of Trustees finds it necessary to amend the Township 2005 Appropriations to cover expenditures that were not anticipated and subsequently not reflected in the Township 2005 Appropriations; and,

WHEREAS, the Butler County Budget Commission must allow the Township Clerk to appropriate the necessary amounts for all Township funds.
