

**RESOLUTION NO. 37- 2005**

**RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A “NO PARKING ZONE” ALONG THE SOUTH SIDE OF WEST CHESTER ROAD BETWEEN UNION CENTRE BOULEVARD AND MUHLHAUSER ROAD; ON ALLEN ROAD FROM UNION CENTRE BOULEVARD TO MUHLHAUSER ROAD; UNION CENTRE DRIVE ON BOTH SIDES OF THE BP STATION; UNION CENTRE BOULEVARD ON BOTH SIDES FROM ALLEN ROAD TO BECKETT ROAD; BECKETT ROAD NORTH/WEST OF UNION CENTRE BOULEVARD AROUND BECKETT PARK AND LAKOTA DRIVE WEST IN WEST CHESTER TOWNSHIP**

**WHEREAS**, West Chester Township Trustees are empowered by Ohio Revised Code §§ 505.17(A) and 4511.07(A) to regulate vehicle parking within the unincorporated area of the Township; and,

**WHEREAS**, the West Chester Township Police Department has determined that vehicle parking in the above-referenced areas within the Union Centre area in West Chester Township has become a hazard to vehicle, bike, and pedestrian traffic, especially within the vicinity of schools; and,

**WHEREAS**, West Chester Township Trustees agree with police officials that a “No Parking Zone” along the south side of West Chester Road between Union Centre Boulevard and Muhlhauser Road; on Allen Road from Union Centre Boulevard to Muhlhauser Road; Union Centre Drive on both sides of the BP Station; Union Centre Boulevard on both sides from Allen Road to Beckett Road; Beckett Road north/west of Union Centre Boulevard around Beckett Park and Lakota Drive West is reasonably necessary to preserve the health, safety, and welfare of Township residents; and,

**WHEREAS**, notice of this proposed “No Parking Zone” has been posted in conspicuous places along the affected streets, and property owners have been notified accordingly; and,

**WHEREAS**, notice has been duly published in a newspaper of general circulation in the Township.

**NOW, THEREFORE, BE IT RESOLVED** that the West Chester Township Board of Trustees hereby agrees to:

**SECTION 1.** Establish a “No Parking Zone” along the south side of West Chester Road between Union Centre Boulevard and Muhlhauser Road; on Allen Road from Union Centre Boulevard to Muhlhauser Road; Union Centre Drive on both sides of the BP Station; Union Centre Boulevard on both sides from Allen Road to Beckett Road; Beckett Road north/west of Union Centre Boulevard around Beckett Park and Lakota Drive West in West Chester Township, effective thirty (30) days from the date this resolution is approved and signed.




**SECTION 2.** Post for thirty (30) days prior to the effective date of enforcement, notice of this proposed "No Parking Zone" in five (5) conspicuous public places in the Township:

- a. Township Police Department, 9577 Beckett Road
- b. Middletown Branch Public Library, 7900 Cox Road
- c. Voice Of America, 8070 Tylersville Road
- d. West Chester Post Office, 8730 Cincinnati-Dayton Road
- e. Township Administration Building, 9113 Cincinnati-Dayton Road


**SECTION 3.** Determine that any violation of this "No Parking Zone" regulation constitutes a minor misdemeanor; and,

**SECTION 4.** Authorize the Board or its designated agent to order into storage any vehicle parked in violation of this parking regulation.



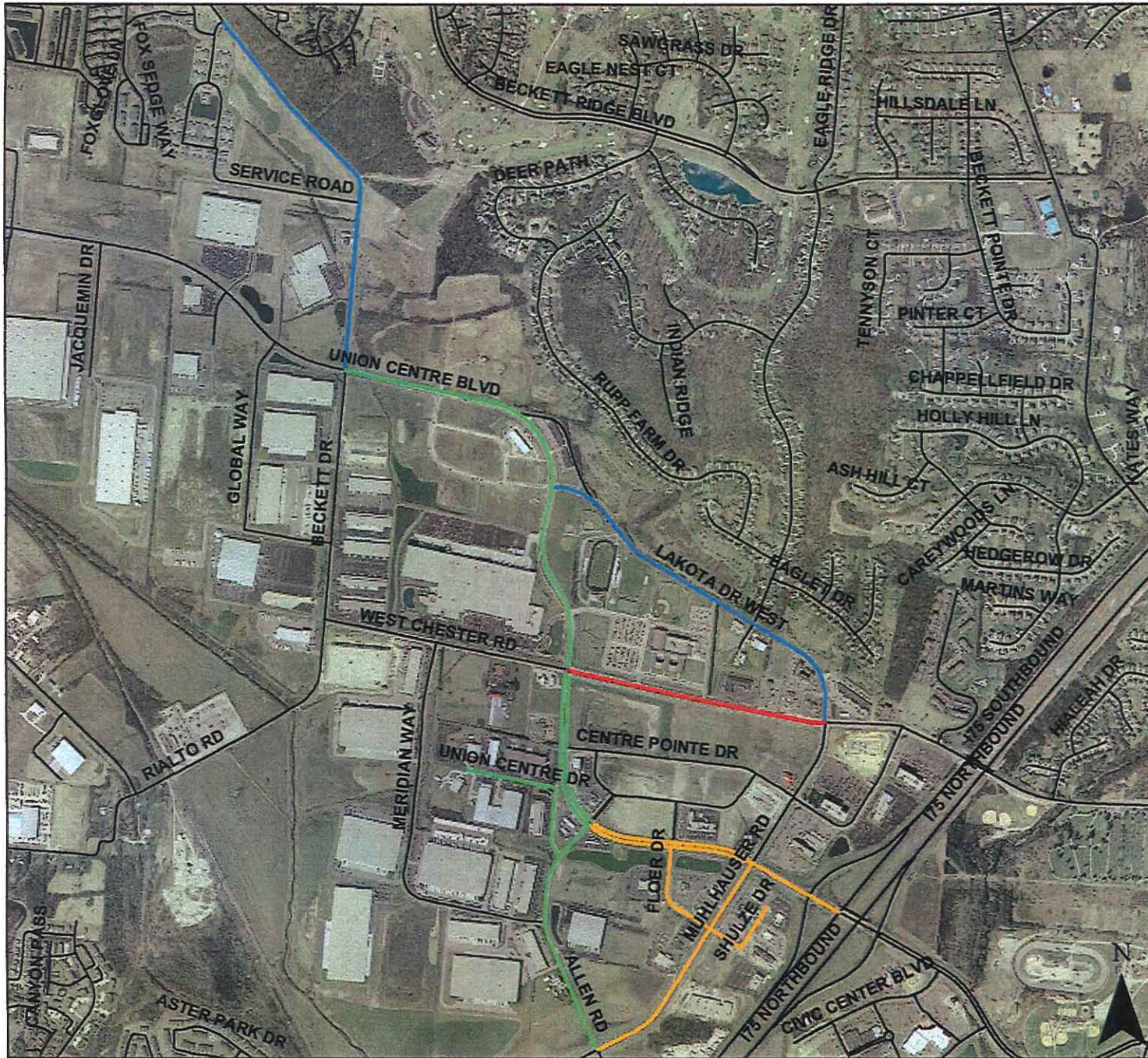


# West Chester Township: Proposed No Parking Zones
