

STATUTORY RESOLUTION NO. 08-2016

**RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A “NO PARKING ZONE”
RESTRICTING VEHICLE PARKING AT ANY TIME FOR THE ENTIRE LENGTH AND ON
BOTH SIDES OF WUNNENBERG WAY AND SHEPHERD FARM DRIVE**

WHEREAS, the West Chester Township Board of Trustees is authorized by Ohio Revised Code §505.17 to regulate vehicle parking within the unincorporated area of the Township; and,

WHEREAS, Ohio Revised Code §4511.07(1) allows further restriction to regulate the parking, standing or stopping of vehicles; and,

WHEREAS, it has been determined vehicle parking for the entire length and on both sides of Wunnenberg Way and Shepherd Farm Drive is a hazard to and creates conflicts for, between, and among emergency, passenger, and service vehicles; and,

WHEREAS, the West Chester Township Board of Trustees has determined regulation of no parking at any time for the entire length and on both sides of Wunnenberg Way and Shepherd Farm Drive is necessary to preserve the health, safety, and welfare of Township residents, commuters, and business patrons; and a “No Parking Zone”, restricting parking at any time should be established at the following location:

The entire length and both sides of Wunnenberg Way and Shepherd Farm (Exhibit A); and,

WHEREAS, notice of this proposed “No Parking Zone”, restricting vehicle parking at any time has been posted in conspicuous places along the affected streets, and property owners have been notified accordingly; and,

WHEREAS, notice of a public hearing was published in two newspapers of general circulation in the Township; and,

WHEREAS, on March 22, 2016, during one of its regularly scheduled meetings, the West Chester Township Board of Trustees conducted a public hearing where any interested or concerned citizen could attend and voice his opinion on the subject proposed “No Parking Zone”, restricting parking at any time.

NOW, THEREFORE, BE IT RESOLVED the West Chester Township Board of Trustees hereby agrees to:

SECTION 1. Establish a “No Parking Zone”, restricting vehicle parking at any time for the entire length and on both sides of Wunnenberg Way and Shepherd Farm Drive, effective thirty (30) days from the date this Resolution is approved and signed.

SECTION 2. Publish notice of the proposed “No Parking Zone” restricting vehicle parking at any time for the entire length and on both sides of Wunnenberg Way and Shepherd Farm Drive, in a newspaper of general circulation in the Township for three consecutive weeks prior to the effective


date of enforcement; and post notice of the proposed "No Parking Zone", restricting vehicle parking at any time for the entire length and on both sides of Wunnenberg Way and Shepherd Farm Drive, for thirty (30) days prior to the effective date of enforcement in five conspicuous public places in the Township:

1. West Chester Police Department – 9577 Beckett Road, Suite 500
2. MidPointe West Chester Library – 9363 Centre Pointe Drive
3. West Chester Activity Center – 7900 Cox Road
4. West Chester Administration Building – 9113 Cincinnati-Dayton Road
5. MetroParks Ronald Reagan Lodge at Voice of America Park – 7850 VOA Park Drive


SECTION 3. Determine any violation of this parking regulation for the "No Parking Zone" constitutes a minor misdemeanor.

SECTION 4. Authorize the Board or its designated agent, the West Chester Police Department, to order into storage any vehicle in violation of this Resolution.
