

RESOLUTION NO. 27-2004

**RESOLUTION AUTHORIZING THE TOWNSHIP CLERK TO
AMEND THE TOWNSHIP 2004 APPROPRIATIONS AND TO
REQUEST THE BUTLER COUNTY BUDGET COMMISSION TO
AMEND THE WEST CHESTER TOWNSHIP CERTIFICATE OF
ESTIMATED RESOURCES FOR BUDGET YEAR 2004**

WHEREAS, the West Chester Township 2004 Appropriations were approved by the Board of Trustees on March 23, 2004 and certified to the Butler County Budget Commission; and,

WHEREAS, the Board of Trustees finds it necessary to amend the Township 2004 Appropriations to cover expenditures that were not anticipated and subsequently not reflected in the Township 2004 Appropriations; and,

WHEREAS, the Butler County Budget Commission must allow the Township Clerk to appropriate the necessary amounts for the Purdue Pharma Grant, the Assistance to Firefighters Grant FY02, and the Assistance to Firefighters Grant FY03 special revenue funds.

NOW, THEREFORE BE IT RESOLVED, that the West Chester Township Board of Trustees does hereby agree to:

SECTION 1. Authorize the Township Clerk to amend the 2004 Appropriations as follows:
