**RESOLUTION AUTHORIZING THE EXCHANGE OF MAINTENANCE RESPONSIBILITIES  
FOR PORTIONS OF WEST CHESTER ROAD AND COX ROAD BY THE BUTLER  
COUNTY ENGINEER AND WEST CHESTER TOWNSHIP**

**WHEREAS**, the Butler County Engineer is currently responsible for the maintenance of West Chester Road from Cincinnati-Dayton Road to Butler Warren Road and Cox Road from Tylersville Road to US 42; and West Chester Township is responsible for the maintenance of West Chester Road from Union Centre Boulevard to Muhlhauser Road and Cox Road from Hamilton Mason Road to Tylersville Road; and,

**WHEREAS**, the portions of West Chester Road and Cox Road now maintained by Butler County are more in character of a Township road and the portions of West Chester Road and Cox Road now maintained by West Township are more in character of a county road; and,

**WHEREAS**, the exchange of these maintenance responsibilities would result in cost savings for each jurisdiction, promote economy and efficiency, and operate in the best interests of the citizens of West Chester Township and Butler County; and,

**WHEREAS**, such exchange of county and township roads is authorized by law.

**NOW THEREFORE, BE IT RESOLVED** that the West Chester Township Board of Trustees does hereby agree to the following exchange of road maintenance responsibilities between West Chester Township and the Butler County Engineer.

**SECTION 1.** For a total of 624,140 square feet of road way, the Butler County Engineer's Office will maintain West Chester Road from Union Centre Boulevard to Muhlhauser Road including the signal at Muhlhauser Road/Lakota Drive West, raised pavement and thermal plastic markings, curb and gutter section, and paved ditch; and, Cox Road from Hamilton Mason Road to Tylersville Road including the traffic signals, the thermal plastic pavement marking, curb and gutter section, including the five foot bike lane on each side of the road.

**SECTION 2.** For a total of 747,138 square feet of roadway, West Chester Township will maintain West Chester Road from Cincinnati-Dayton Road to Butler Warren Road, including intersection and pavement repair; and Cox Road from Tylersville Road to Ohio State Route 42 including five foot bike lane on each side from Tylersville Road to Barret Road and turn lanes at Ohio State Route 42, but excluding the traffic signal at Barret Road and Cox Road, maintenance of which will remain with the Butler County Engineer.
