

**STATUTORY RESOLUTION NO. 18-2016**

**RESOLUTION FINDING ONE 2009 CROWN VICTORIA MODEL FORD AND SEVEN 2010 CROWN VICTORIA MODEL FORDS AND EXISTING EQUIPMENT FOR EACH VEHICLE ARE NOT NEEDED OR ARE UNFIT FOR PUBLIC USE; AUTHORIZING THE SALE OF SAID VEHICLES AND EXISTING EQUIPMENT TO CAMP SAFETY EQUIPMENT COMPANY; AND CREDITING THE SALE PRICE OF SAID VEHICLES AND EXISTING EQUIPMENT TO THE PURCHASE OF ADDITIONAL NECESSARY EQUIPMENT AND TO THE REINSTALLATION OF SOME EXISTING EQUIPMENT AND GRAPHICS TO COMPLETELY EQUIP EIGHT NEW POLICE VEHICLES**

**WHEREAS**, pursuant to Ohio Revised Code §505.10(3) West Chester Township (“Township”) may sell equipment not needed or unfit for public use and have the sale price credited to the purchase of other equipment; and,

**WHEREAS**, the Township finds one 2009 Crown Victoria model Ford, seven Crown Victoria model Fords and existing equipment for each vehicle are not needed or are unfit for public use and for the use for which they were purchased; and,

**WHEREAS**, Camp Safety Equipment Company has offered a trade-in value of \$14,100.00 toward the purchase of additional equipment and the reinstallation of existing equipment and graphics to completely equip eight) new police vehicles.

**NOW THEREFORE, BE IT RESOLVED** the West Chester Township Board of Trustees hereby agrees to:

**SECTION 1.** Sell the not needed or unfit vehicles and existing equipment to Camp Safety Equipment Company and credit the \$14,100.00 sale price of the vehicles and existing equipment to the purchase of additional necessary equipment and to the reinstallation of existing equipment and graphics to completely equip eight (8) new police vehicles.


