RESOLUTION NO. 43 - 2003

RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A SPECIAL REVENUE FUND ENTITLED "DRIVING UNDER THE INFLUENCE (DUI) TASK FORCE GRANT FUND"

WHEREAS, the West Chester Township Police Department, in conjunction with other Butler County law enforcement agencies, applies numerous resources – personnel, tools, and equipment, informing and educating the traveling public of the dangers to self and others of driving under the influence; and,

WHEREAS, the Butler County law enforcement agencies have pooled their resources and addressed the dangers of this problem as a unified DUI task force; and,

WHEREAS, the Butler County DUI Task Force annually applies for and generally receives federal monies to fund the efforts and programs of the task force activities and annually a local law enforcement jurisdiction is selected to financially administer the grant; and,

WHEREAS, the West Chester Police Department has been selected to financially administer the DUI Task Force federal grant for fiscal year 2004, commencing October 1, 2003 through September 30, 2004; and,

WHEREAS, the Board of Trustees has determined that the current Township fund structure does not account for nor provide all relevant information that will account for the revenue and expenditures generated by the DUI Task Force operations and funded by the federal grant; and,

WHEREAS, the Ohio Revised Code Section 5705.12 permits, by Resolution, Township Trustees to create new funds; and,

WHEREAS, the Board of Trustees determines it necessary to create a new fund to account for and to provide all relevant information for the DUI Task Force operations.

NOW THEREFORE BE IT RESOLVED, that the West Chester Township Board of Trustees does hereby agree to:

SECTION 1. Authorize the Township Clerk/Treasurer to establish a special revenue fund entitled "DRIVING UNDER THE INFLUENCE (DUI) TASK FORCE GRANT FUND" to account for all DUI Task Force operations.
