## RESOLUTION AUTHORIZING THE TOWNSHIP CLERK TO AMEND THE TOWNSHIP 2003 APPROPRIATIONS AND TO REQUEST THE BUTLER COUNTY BUDGET COMMISSION TO AMEND THE WEST CHESTER TOWNSHIP CERTIFICATE OF ESTIMATED RESOURCES FOR BUDGET YEAR 2003

WHEREAS, the West Chester Township 2003 Appropriations were approved by the Board of Trustees on December 3, 2002 and certified to the Butler County Budget Commission on March 6, 2003; and,

WHEREAS, the Board of Trustees finds it necessary to amend the Township 2003 Appropriations to cover expenditures that were not anticipated and subsequently not reflected in the Township 2003 Appropriations; and,

WHEREAS, the Butler County Budget Commission must allow the Township Clerk to appropriate the necessary amounts for the General Fund, Cable Center Fund, Motor Vehicle Tax Fund, Gasoline Tax Fund, Road and Bridge Fund, Cemetery Fund, Parks and Recreation Fund, Police District Fund, Fire District Fund, Union Centre Boulevard TIF Fund, 747 TIF Fund, DUI Task Force Grant Fund, Union Centre Boulevard TIF Capital Projects Fund, 747 TIF Capital Projects Fund, Union Centre Boulevard TIF Debt Service Fund, 747 TIF Debt Service Fund, Lighting Assessment Fund, Cemetery Bequest Fund, and Park Trust Fund.
