**RESOLUTION AUTHORIZING THE ADOPTION OF  
TEMPORARY APPROPRIATIONS FOR YEAR 2004**

**WHEREAS**, the Board of Township Trustees is required to pass a temporary or permanent Appropriations resolution for year 2004 on or before January 1, 2004; and,

**WHEREAS**, the Board of Trustees finds it necessary to adopt Resolution 47-2003 for Temporary Appropriations for the first quarter of 2004 and will adopt a subsequent resolution, pursuant to statutory requirements, for Permanent Appropriations for 2004.




