# RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR

**WHEREAS,** by the Board of Township Trustees of West Chester Township, Butler County, Ohio, in accordance with statute has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1<sup>st</sup>, 2003; and
