

RESOLUTION NO. 25 - 2002

**RESOLUTION ACCEPTING THE AMOUNTS AND RATES
AS DETERMINED BY THE BUDGET COMMISSION
AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING
THEM TO THE COUNTY AUDITOR**

WHEREAS, by the Board of Township Trustees of West Chester Township, Butler County, Ohio, in accordance with statute has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1st, 2003; and

WHEREAS, the Budget Commission of Butler County, Ohio has certified its action thereon to the Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board, and what part thereof is without, and what part within the ten mill tax limitation;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees, West Chester Township, Butler County, Ohio do hereby resolve:

Section 1. That the Board of Trustees of West Chester Township, Butler County, Ohio, accepts the amounts and rates, as determined by the Budget Commission in its certification; and

Section 2. That there be, and is hereby levied on the tax duplicate of said Township, the rate of each tax necessary to be levied within and without the ten mill limitation as follows:
