## RESOLUTION AUTHORIZING THE EXCHANGE OF MAINTENANCE RESPONSIBILITIES FOR PORTIONS OF WEST CHESTER ROAD AND LAKOTA DRIVE WEST BY THE BUTLER COUNTY ENGINEER AND WEST CHESTER TOWNSHIP

WHEREAS, the Butler County Engineer is currently responsible for the maintenance of .77 miles of Lakota West Drive, and West Chester Township is responsible for the maintenance of .83 miles of West Chester Road from Union Centre Boulevard to I-75; and

WHEREAS, Lakota West Drive is more a Township road in character and portions of West Chester Road is currently maintained by the Butler County Engineer; and

WHEREAS, the exchange of these maintenance responsibilities would result in cost savings for each jurisdiction, promote economy and efficiency and operate in the best interests of the citizens of West Chester Township and Butler County; and

WHEREAS, such exchange among neighboring jurisdictions is authorized by law;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF WEST CHESTER TOWNSHIP, BUTLER COUNTY, OHIO THAT THE WEST CHESTER BOARD OF TRUSTEES APPROVES THE FOLLOWING EXCHANGE OF ROAD MAINTENANCE RESPONSIBILITIES BETWEEN WEST CHESTER TOWNSHIP AND THE BUTLER COUNTY ENGINEER.

<u>Section 1</u>. West Chester Road from Union Centre Boulevard to I-75, a distance of .83 miles will be maintained as a Butler County Road by the Butler County Engineer provided that landscaping and mowing of the median beyond normal maintenance is the responsibility of the Township or some future landowners' association.

<u>Section 2</u>. The Township will assume responsibility for Lakota Drive West, upon satisfactory inspection of same by our Road Superintendent, from Union Centre Boulevard to West Chester Road, a distance of approximately .77 miles.
