RESOLUTION NO. 51-2001

RESOLUTION AUTHORIZING THE TOWNSHIP CLERK TO AMEND THE TOWNSHIP 2001 APPROPRIATIONS AND TO REQUEST THE BUTLER COUNTY BUDGET COMMISSION TO AMEND THE WEST CHESTER TOWNSHIP CERTIFICATE OF ESTIMATED RESOURCES FOR BUDGET YEAR 2001 AND DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the West Chester Township 2001 Appropriations were approved by the Board of Trustees and certified to the Butler County Budget Commission on February 13, 2001; and

WHEREAS, the Board of Trustees finds it necessary to amend the Township 2001 Appropriations to cover expenditures that were not anticipated in the Township 2001 Appropriations; and

WHEREAS, the Butler County Budget Commission must allow the Township Clerk to appropriate the necessary amounts for the General Fund (Street Lighting), Union Centre Boulevard Tax Incremental Equivalent Fund, State Route 747 Tax Incremental Equivalent Fund, Union Centre Boulevard TIF Capital Projects Fund, State Route 747 TIF Capital Projects Fund, Union Centre Boulevard TIF Debt Service Fund, and State Route 747 TIF Debt Service Fund;

WHEREAS, Resolution #46-2001 was presented for a first reading to the West Chester Township Board of Trustees on December 4, 2001 with inaccuracies and is thereby rescinded and replaced with Resolution #51-2001.

NOW THEREFORE BE IT RESOLVED, that the West Chester Township Board of Trustees do hereby agree to:
