

RESOLUTION NO. 2000-08

**A RESOLUTION APPROVING CHANGES TO THE
STREET LIGHTING SYSTEM AND ESTABLISHING THE
TYLER'S RESERVE LIGHTING DISTRICT
AND DISPENSING WITH THE SECOND READING
AND DECLARING AN EMERGENCY**

WHEREAS, the Board of Trustees has determined the need for changes in the street lighting system; and

WHEREAS, the Public Utilities Commission of Ohio has established certain rates and regulations regarding street lights provided by CG&E in townships;

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Union Township, Butler County, State of Ohio, that the public welfare and safety requires the following changes to the street lighting system:

**Tyler's Reserve Subdivision Section I
Lighting District**

CERTIFICATION

Section 1: That the Cincinnati Gas & Electric Company be and it hereby is authorized and directed to make the aforementioned change in the street lighting system, including the installation and/or replacement of all necessary poles, wires and anchors, and installing 25, 9500 lumen Sodium Vapor Lights, and that the Clerk hereby is authorized and directed to notify the Company of the action of the Board of Trustees by transmitting to the Company a certified copy of this Resolution.

Section 2: That such changes to the street lighting system be made consistent with The Cincinnati Gas & Electric Company's filed street lighting service tariff, P.U.C.O. No. 17, Sheet No. 60.7 or amendments or Revisions thereof.

Section 3: That this Resolution shall take affect and be in force from and after the earliest period allowed by law.

This resolution shall be adopted as an emergency necessary for the immediate preservation of the public peace, health, safety, or welfare of the community.
