**A RESOLUTION REQUESTING THAT BUTLER COUNTY AND STATE OFFICES
BE NOTIFIED TO CHANGE MAPS AND RECORDS TO REFLECT THE NAME
CHANGE FROM UNION TOWNSHIP TO WEST CHESTER TOWNSHIP**

WHEREAS, on March 7, 2000 the electors of Union Township voted to change the name of Union Township to West Chester Township; and

WHEREAS, on March 30, 2000, the Butler County Board of Elections certified the result by the issuance of the Certificate of Official Result of Election for the Primary Election held on March 7, 2000; and

WHEREAS, pursuant to the Ohio Revised Code, the name change from Union Township to West Chester Township shall become effective on June 28, 2000; and

WHEREAS, it is necessary to pass a resolution authorizing the Butler County Engineer's Office and other Butler County and State of Ohio offices to change tax maps and any other necessary documents and records to reflect the name change from Union Township to West Chester Township.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES, UNION TOWNSHIP, BUTLER COUNTY, OHIO:

Section 1. The Board of Trustees, Union Township, Butler County, Ohio hereby authorizes and directs the Township Administrator to take all actions that are necessary and proper to cause the Butler County Engineer's Office, Butler County and State of Ohio offices, and other civic and governmental offices to change tax maps and any other necessary records and documents to reflect the name change from Union Township to West Chester Township effective June 28, 2000.
