RESOLUTION NO. 2000-20

A RESOLUTION APPROVING REIMBURSEMENT TO HIGGINS DEVELOPMENT PARTNERS LLC THROUGH TAX INCREMENT FINANCING FOR COST OF CONSTRUCTION OF CENTRE POINT DRIVE

WHEREAS, pursuant to Ohio Revised Code 5709.73, et. seq., the Union Township Board of Trustees created a Tax Increment Finance (TIF) District in April 1990 and amended in July 1991, declaring that certain public improvements were necessary for the further development of the parcels of land described in the subject TIF District; and

WHEREAS, on two (2) separate occasions, General Obligation Notes, totaling approximately \$7.87 Million, were issued and sold to finance the cost of making improvements to the Township road system, including land acquisition, construction, planning and legal costs; and

WHEREAS, the public improvements were completed and numerous development projects have been constructed, namely Cornerstone Services, Inc. distribution facility, the full service Marriott Hotel with conference facilities, various retail establishments, the first corporate office building of Centre Point Office Park developed by Higgins Development Partners, LLC, and others; and

WHEREAS, Higgins Development Partners, LLC had Centre Point Drive constructed, a road for the public benefit, connecting West Chester and Muhlhauser Roads, using competitive bidding and paying union scale wages as required by the Ohio Revised Code; and

WHEREAS, Higgins Development Partners, LLC has requested that the Board of Trustees use tax increment finance funding to reimburse them for the cost of Centre Point Drive, approximately \$1.275 Million and in return, they agree to construct the second 125,000 s.f. corporate office building of Centre Point Office Park; and

WHEREAS, the Township's engaged bond counsel, Peck, Shaffer & Williams, has reviewed the reimbursement agreement and found no basis to object to the transaction;

NOW, THEREFORE BE IT RESOLVED, that the Union Township Board of Trustees does hereby agree to reimburse Higgins Development Partners, LLC \$1.275 Million, using tax increment finance funding, for the construction of Centre Point Drive, a public road connecting West Chester and Muhlhauser Roads.
