

RESOLUTION NO. 2000-40

**RESOLUTION AUTHORIZING THE ADOPTION OF TEMPORARY
APPROPRIATIONS FOR YEAR 2001**

WHEREAS, the Ohio Revised Code Section 5705.38 requires that on or about the first day of January the Township Trustees must adopt a temporary appropriation resolution; and

WHEREAS, the temporary appropriation resolution is needed to expend funds until an Amended Certificate of Estimated Resources is available and a permanent resolution can be adopted; and

WHEREAS, the Board of Trustees finds it necessary to adopt a temporary appropriation resolution for the year 2001;

NOW THEREFORE BE IT RESOLVED, that the West Chester Township Board of Trustees does hereby agree to:
