BE IT RESOLVED by the Township Trustees of Union Township, Butler County, Ohio that:

A RESOLUTION TO SUBMIT THE QUESTION OF A TAX LEVY TO PROVIDE FUNDS FOR FIRE EQUIPMENT AND SERVICES PURSUANT TO SECTION 5705.19(I) OF THE OHIO REVISED CODE

BE IT RESOLVED, by the Board of Township Trustees of Union Township, Butler County, Ohio, that:

Section 1. This Board hereby determines and declares that the amount of taxes that may be raised within the 10-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount of revenue to provide for the necessary requirements of Union Township, Butler County, Ohio and that it is therefore necessary to levy an additional tax in excess of the 10-mill limitation providing funds for the purpose of providing and maintaining fire apparatus, appliances, buildings, or sites therefor, or sources of water supply and materials therefor, or the establishment and maintenance of lines of fire alarm telegraph, or the payment of permanent, part-time, or volunteer firefighters or fire-fighting companies to operate the same, including the payment of the firefighters employer's contribution required under section 742.34 of the Revised Code, or to purchase ambulance equipment, or to provide ambulance, paramedic, or other emergency medical services operated by a fire department or fire-fighting company, in Union Township, Butler County, Ohio at a rate not exceeding 4.5 mills for each One Dollar of valuation, for a continuing period of time commencing with a levy on the duplicate of the current tax year.

Section 2. The question of such tax levy not exceeding 4.5 mills for a continuing period of time commencing with the current tax year of 1999 to provide funds for the purpose of providing and maintaining fire apparatus, appliances, buildings, or sites therefor, or sources of water supply and materials therefor, or the establishment and maintenance of lines of fire alarm telegraph, or the payment of permanent, part-time, or volunteer firefighters or fire-fighting companies to operate the same, including the payment of the firefighters employer's contribution required under section 742.34 of the Revised Code, or to purchase ambulance equipment, or to provide ambulance, paramedic, or other emergency medical services operated by a fire

department or fire-fighting company, in Union Township, Butler County, Ohio, shall be submitted to the electors of the Township at the general election to be held on November 2, 1999, as authorized by law.

Section 3. The Clerk of this Board is hereby directed to certify a copy of this resolution to the Board of Elections of Butler County.

Section 4. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
