BE IT RESOLVED by the Township Trustees of Union Township, Butler County, Ohio that:

A RESOLUTION STATING THE SENSE OF THE BOARD
OF TRUSTEES REGARDING THE LEVY OF TAXES TO
PROVIDE FUNDS FOR FIRE EQUIPMENT AND
SERVICES.

BE IT RESOLVED, by the Board of Township Trustees of Union Township, Butler County, Ohio, that:

Section 1. This Board has previously determined in Resolution No. 27-99 that the amount of taxes which may be raised within the 10-mill limitation by levies on the current tax duplicate will be insufficient to provide adequate revenues to provide funds for the purpose of providing and maintaining fire apparatus and supporting equipment and fire fighting services, including ambulance and emergency medical services to be provided through the fire department and therefore determined to submit an additional tax of 4.5 mills for approval by the electors. The Board recognizes that Union Township currently levies a 3.5 mill levy being for the purpose of providing and maintaining fire apparatus, appliances, buildings and the payment of permanent, part-time and volunteer firemen.

Section 2. It is the sense of this Board and it is hereby expressly stated that it is, in the event the proposed additional tax levy for fire equipment and services as adopted by this Board in Resolution No. 27-99 is approved by the electors, it is the intention of this Board to adopt a resolution within the requirements of Section 5705.19 of the Revised Code to terminate the existing levy of 3.5 mills as adopted November 2, 1993, such termination to be effective for the same tax year as Resolution No. 27-99 may become effective.

BE IT RESOLVED by the Township Trustees of Union Township, Butler County, Ohio that:

RESOLUTION OF THE BOARD OF TOWNSHIP TRUSTEES, UNION TOWNSHIP, BUTLER COUNTY, OHIO

RESOLUTION DECLARING THE NECESSITY
OF LEVYING AN ADDITIONAL TAX IN
EXCESS OF THE TEN-MILL LIMITATION
AND REQUESTING THE COUNTY AUDITOR
TO CERTIFY MATTERS IN CONNECTION
THEREWITH

WHEREAS, this Board of Township Trustees anticipates levying an additional tax in excess of the ten-mill limitation as described herein:

WHEREAS, pursuant to Section 5705.03 of the Ohio Revised Code this Board of Township Trustees is required to certify to the county auditor a resolution requesting the county auditor to certify certain matters in connection with such a tax levy:

NOW THEREFORE BE IT RESOLVED by the Board of Township Trustees of Union Township, Butler County, Ohio:

SECTION 1. That pursuant to the provisions of Section 5705.19(I) of the Ohio Revised Code, it is necessary that an additional tax be levied in excess of the ten-mill limitation for the benefit of this Township for the purpose of providing and maintaining fire apparatus, appliances, buildings, or sites therefor, or sources of water supply and materials therefor, or the establishment and maintenance of lines of fire alarm telegraph, or the payment of permanent, part-time, or volunteer firefighters or fire-fighting companies to operate the same, including the payment of the firefighters employer's contribution required under Section 742.34 of the Revised Code, or to purchase ambulance equipment, or to provide ambulance, paramedic, or other emergency medical services operated by a fire department or fire-fighting company, in Union Township, Butler County, Ohio at a rate not exceeding 4.5 mills for each One Dollar of valuation, for a continuing period of time commencing with a levy on the duplicate of the current tax year.

SECTION 2. That the question of the passage of said tax levy shall be submitted to the electors of the Township at an election to be held on November 2, 1999. If approved by the electors, said tax levy shall first be placed upon the tax list and duplicate, for first collection in the current year.

SECTION 3. That pursuant to Section 5705.03 of the Ohio Revised Code, the county auditor is hereby requested to certify to this Board the total current tax valuation of the Township and the dollar amount of revenue that would be generated by the number of mills specified in Section 1 hereof, and the Clerk of this Board be and is hereby directed to certify forthwith a copy of this resolution to the county auditor at the earliest possible time so that said county auditor may certify such matters in accordance with such Section 5705.03.

SECTION 4. That it is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
