## RESOLUTION NO. 47-99

BE IT RESOLVED by the Township Trustees of Union Township, Butler County, Ohio that:

WHEREAS, by advertisement, a public hearing to amend the Union Township Zoning Resolution was held on September 20, 1999 as applied for by Mark Sennet, Beckmark Inc. (04-99) to redistrict from A-1 (Agricultural District) to M-1 (Light Industrial) for the following described property:

Situated in Section 18, Town 3, Range 2, Union Township Butler County, Ohio, and being further bounded and described as follows:

Beginning in the north line of said Section 18, at a point which is North 88<sup>0</sup> 05' 19" West, 120.00 feet from the northeast corner of said Section 18; thence from said beginning point and along the west line of a 1.003 acre tract owned by Darin & Teresa Rothert (Deed Book 1632, Page 129, Butler County Deed Records) South 02<sup>0</sup> 39' 41" West, 364.00 feet; thence along the south line of said 1.003 acre tract, South 88<sup>0</sup> 05' 19" East, 120.00 feet to a point in the east line of said Section 18; thence along said east line South 02<sup>0</sup> 39' 41" West, 593.49 feet to the northeast corner of Beacon Point Subdivision; thence along the northwardly line of said subdivision, North 82<sup>0</sup> 19' 39" West, 665.75 feet to the easterly line of Interstate 75; thence along said easterly line and curving to the left along the arc of a circle, having a radius of 12447.67 feet for an arc length of 896.16 feet and subtended by a chord bearing of North 08<sup>0</sup> 10' 58" East, 895.97 feet to a point in the north line of said Section 18; thence along the north line of said section South 88<sup>0</sup> 05' 19" East, 457.04 feet to the point of beginning containing 12.0747 acres of land.
