WHEREAS, the Public Utilities Commission of Ohio has established certain rates and regulations regarding street lights provided by CG&E in Townships. NOW THEREFORE:

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF UNION TOWNSHIP, BUTLER COUNTY, STATE OF OHIO:

#### Section I

That the public welfare and safety requires the following changes to the street lighting system:

The addition of 5 lights along Beckett Road:

50,000 Lumen high pressure sodium - pole #56BT-135E

50,000 Lumen high pressure sodium - pole #56BT-519E

50,000 Lumen high pressure sodium - pole #56BT-520E

50,000 Lumen high pressure sodium - pole #56BT-522E -

50,000 Lumen high pressure sodium - pole #56BT-1192E

#### CERTIFICATION

#### Section II

That The Cincinnati Gas & Electric Company be and it hereby is authorized and directed to make the aforementioned change in the street lighting system, including the installation and/or replacement of all necessary poles, wires and anchors, and that the Clerk hereby is authorized and directed to notify the Company of the action of the Board of Trustees by transmitting to the Company a certified copy of this Resolution.

### Section III

That such changes to the street lighting system be made consistent with The Cincinnati Gas & Electric Company's filed street lighting service tariff, P.U.C.O. No. 17, Sheet No. 60.4 or amendments or revisions thereof.

That this Resolution shall take affect and be in force from and after the earliest period allowed by law.
