WHEREAS, a request has been made to this Board that the statutory vehicular speed limit established by Sec. 4511.21, Revised Code of Ohio is greater (or less) than considered reasonable and safe on Rialto Road from the intersection of State Route 747 to the intersection of Port Union and Rialto Road,

WHEREAS, this Board has cause to be made an engineering and traffic investigation upon the section of road described above, and

WHEREAS, it is the belief of this Board that such investigation confirms the allegation that the statutory speed limit of 55 mph is unrealistic,

NOW THEREFORE, BE IT RESOLVED by the Board of Union Township Trustees of Butler County, Ohio, that:

Section 1. By virtue of the provisions of Sec. 4511.21, Revised Code of Ohio, the Director of Highways is hereby requested to review the engineering and traffic investigation and to determine and declare a reasonable and safe prima facie speed limit on Rialto Road from the intersection of State Route 747 to the intersection of Port Union and Rialto Road in Butler County, Ohio.

Section 2. That when this Board is advised that the Director of Highways has determined and declared a reasonable and safe speed limit on the section of road described in Section 1 hereof, standard signs, properly posted and giving notice thereof will be erected.

It has come to my attention that the statutory speed limit of 55 mph on Rialto Road from the intersection of State Route 747 to the intersection of Port Union Road and Rialto Road is unrealistic. With the recent land development and the sharp curves along this road, Union Township feels the speed limit is unsafe and would like to request the Butler County Engineer's Office conduct a traffic study to determine and declare a reasonable and safe prima facie speed limit for the referenced section of Rialto Road.
