BE IT RESOLVED by the Township Trustees of Union Township, Butler County, Ohio that:

RESOLUTION NO. 55-99 AUTHORIZES THE BOARD OF UNION TOWNSHIP TRUSTEES,
BUTLER COUNTY, OHIO TO PURCHASE ADDITIONAL YEARS OF SERVICE CREDIT

WHEREAS, Union Township, Butler County, Ohio desires to create a Pick Up Plan to permit Union Township, Butler County, Ohio to purchase additional years of PERS service credit for the employee described in Section One below:

WHEREAS, Union Township, Butler County, Ohio shall not be permitted to pay such amounts to the extent it is reimbursed for such payments by the employee described in Section One below; and

WHEREAS, the employee shall not have the option to receive such amounts in cash in lieu of having such amounts paid to the PERS on their behalf, now therefore, be it

RESOLVED, that effective 1 January 2000, Union Township, Butler County creates a Pick Up Plan to permit Union Township, Butler County, Ohio to "pick up" and pay such amounts which Union Township, Butler County determines be paid for the purchase of additional years of PERS service credit, provided that Union Township, Butler County shall not be permitted to pay such amounts to the extent that Union Township, Butler County is reimbursed for such amounts by the employee described in Section One below, nor shall such employee described in Section One have the option to receive such payments in cash in lieu of having such amounts paid directly to PERS.

SECTION ONE The employee to whom this Resolution applies is Township Administrator.

SECTION TWO The Township Clerk is hereby authorized and directed to implement the provisions of this Resolution to expand the funds necessary to purchase five (5) additional years of PERS service credit over the next forty-eight (48) months pursuant to the Ohio Revised Code Sections 145-301, and that such purchase be "picked up" (within the meaning of IRC Section 414(H)(2)).

Be it hereby resolved, that the Board of Union Township Trustees shall beginning the first regular pay period in the year 2000, through monthly payroll (tax deferred) payments, "pay and pick up" for Mr. Gully, the cost to purchase 5 years military services credit in the Ohio Public Employees Retirement System (Sec. 145-301 O.R.C.) at a rate of \$700.00 per month for a period of 47 months.
