Discussion Items & Trustees Comments: Mr. Lang said he was very impressed with the job done by the Roads crews during the past snow storm. He commented on the Award received for excellence in reporting by the Finance Dept. from State Auditor, Mary Taylor. Kudos go to Ken Keim, Finance Director and the Finance Dept. He also reported on his trip to Washington D.C. for the swearing in of John Boehner as Speaker of the House of Representatives. He emphasized that Mr. Boehner as a citizen of West Chester will be making an impact on the world. He said it was a humbling experience to be there. He then spoke of the tragic experience in Arizona last week and asked for a moment of silence.
