RESOLUTION NO.93-67

BE IT RESOLVED by the Township Trustees of Union Township, Butler County, Ohio that:

WHEREAS, by advertisement, a public hearing to amend the Union Township Zoning Resolution was held on December 14, 1993, on the application of Richard Paul Michaelson (11-93) to redistrict from A-1(Agricultural District) to C-PUD (Commercial Planned Unit Development District), the following described property:

Situated in Section 23, Town 3, Range 2, Union Township, Butler County, Ohio, containing approximately 2.556 acres and is located along the southwest side of Cincinnati-Dayton Road and is further described as follows:

Begin at the northwesterly corner of Lot #3 of Lakeland Subdivision found on the southerly right-of-way line of Lakeland Court (50' R/W):

thence along said right-of-way line and northerly line of Lot #3 South 86*52'15" East 229.72 feet;

thence along a curve to the right an arc distance of 31.41 feet, said curve having a radius of 20.00 feet and a chord bearing South 41*52'15" East 28.28 feet to the westerly right-of-way of Cincinnati-Dayton Road;

thence along said westerly right-of-way line, the same being the easterly line of Lots #3, 2, and 1 of the aforesaid subdivision, and the southerly projection thereof, South 3*07'45" West 434.36 feet to the southerly line of a 0.975 acre tract (of which 0.860 acre lies within the herein described tract);

thence along the southerly line of said tract North 83*08'45" West 250.25 feet to the southwesterly corner of said tract; thence along the westerly line of said tract and the westerly line of the aforesaid lots North 3*07'45" East 438.10 feet to Point of beginning; and

- WHEREAS, all those present for the hearing who wished to be heard voiced their opinions with respect thereto; and
- WHEREAS, the Union Township Zoning Commission recommended approval (Resolution 93-31) of this district change from A-1 to C-PUD District; and
- WHEREAS, said application was reviewed by the Board of Township Trustees and determined to be consistent with the Union Township Land Use Plan.
- THEREFORE BE IT RESOLVED, that by unanimous vote, the Board of Trustees does hereby concur with the recommendation of the Union Township Zoning Commission and approve the district change from A-1 to C-PUD for the aforesaid application, subject to the following stipulations:
 - The proposed access point shown on the Preliminary Development Plan at Lakeland Court be eliminated.
 - All Final Development Plans contain specific information regarding buffering, final location of access points, and all necessary cross easements.
 - All Final Development Plans shall require the dedication of 17 feet of roadway along the frontage of Cincinnati-Dayton Road.
