TOWNSHIP FIVE DOLLAR PERMISSIVE LICENSE TAX (H. B. 419 - 117th General Assembly)

RESOLUTION

A RESOLUTION LEVYING A FIVE DOLLAR MOTOR VEHICLE LICENSE FEE PURSUANT TO SECTION 4504.18 OF THE OHIO REVISED CODE TO PROVIDE REVENUE FOR REPAIR, MAINTENANCE AND CONSTRUCTION FOR TOWNSHIP ROADS.

WHEREAS, Union Township, Butler County, Ohio, is in need of revenue for the purposes set forth in Section 4504.18 of the Ohio Revised Code including the construction, reconstruction, improvement, maintenance and repair of the township roads within the unincorporated area of the township, and;

WHEREAS, the Board of Trustees has conducted two public hearings regarding the proposed adoption of this resolution and provided notice of the date, time and place of such public hearings by publication as provided in Section 4504.18 of the Ohio Revised Code;

THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF
Union TOWNSHIP, Butler
COUNTY, OHIO, THAT:

- (1) An annual license tax, in addition to the tax levies by Sections 4503.02, 4503.07 and 4502.18 of the Ohio Revised Code, be levied by the township upon the operation of motor vehicles on the public roads and highways in the unincorporated territory of the township pursuant to Section 4504.18 of the Ohio Revised code.
- (2) Such tax shall be at the rate of five dollars per motor vehicle on all motor vehicles the district of registration of which, as defined in Section 4504.18 of the Ohio Revised Code, is in the unincorporated area of Union Township,

 Butler County, Ohio.
- (3) Such tax shall be in addition to the taxes at the rates specified in Sections 4503.04 and 4503.16 of the Ohio Revised Code, subject to reductions in the manner provided in Section 4503.11 of the Revised Code and exemptions provided in Sections 4503.16, 4503.17, 4503.171, 4503.41 and 4503.43 of the Ohio Revised Code.
- (4) Such annual license tax shall be collected pursuant to Sections 4505.18 and 4504.19 of the Ohio Revised Code, beginning January 1, 19 88 .
- (5) Said tax shall be used for the purpose of paying the costs and expenses of enforcing and administering the tax provided for in this Section; for the construction, reconstruction, improvement, maintenance and repair of township roads, bridges and culverts; for purchasing, erecting and maintaining traffic signs, markers, lights and signals; for purchasing road machinery and equipment, and planning, constructing and maintaining suitable buildings to house such equipment; for paying any costs apportioned to the township under Section 4907.47 of the Ohio Revised Code; and to supplement revenue already available for such purposes.
- (6) A certified copy of this resolution shall be forwarded to the Ohio Bureau of Motor Vehicles, Tax Distribution Division.
- (7) This resolution shall become effective on the thirtieth day following its adoption.
