A RESOLUTION PRESCRIBING REGULATIONS CONSISTENT WITH NATIONALLY RECOGNIZED STANDARDS FOR SAFEGUARDING, TO A REASONABLE DEGREE, OF LIFE AND PROPERTY FROM THE HAZARDS OF FIRE AND EXPLOSION ARISING FROM THE STORAGE, HANDLING AND USE OF HAZARDOUS SUBSTANCES, MATERIALS AND DEVICES: AND FROM CONDITIONS HAZARDOUS TO LIFE OR PROPERTY IN THE USE OR OCCUPANY OF BUILDINGS OR PRIMISES: KNOWNS AS THE FIRE PREVENTION CODE.

SECTION1. ADOPTION OF BASIC/NATIONAL FIRE PREVENTION CODE.

That a certain document, three (3) copies of which are on file in the office of the Union Township Clerk of Butler County being marked and designated as the "The BOCA Basic/National Fire Prevention Code, 6th Edition, 1984, as published by Building Officials and Code Administrators International, Inc., is hereby adopted as the Fire Prevention Code of the Union Township of Butler County in the state of Ohio; for the control of buildings and structures as herein provided; and each and all of the regulations, provisions, penalties, conditions, and terms of the BOCA Basic/National Fire Prevention Code, 6th Edition, 1984, are hereby referred to, adopted and made a part thereof, as if fully set out in this resolution.

#### SECTION 2. INCONSISTENT RESOLUTIONS REPEALED

That all other resolutions or parts of resolutions in conflict herewith are hereby repealed.

Dear Lt. Connell:

After reviewing our earlier opinions about Township-Adopted Fire Codes in the light of Section 505.373 of the Ohio Revised Code, we have concluded that, contrary to our earlier interpretation, a Board of Township Trustees may adopt any standard Fire Code that has been "prepared and promulgated by a public or private organization".

This broader interpretation will allow the Union Township Trustees to adopt the Building Officials and Code Administrators (BOCA) Basic/National Fire Prevention Code, if the Trustees so desire.

After the adoption of such a code by the Board of Trustees, all other requirements of Section 505.373, particularly as to notice in a newspaper of general circulation for three consecutive weeks must be met.

I apologize for the length of time it has taken me to reach this conclusion and thank you for your patience.



3737.42 Notice of violation, issuance of citation; form, contents, posting.

(A) If, upon inspection or investigation, the fire marshal, his authorized representative, or a certified fire safety inspector believes that the state fire code, or any order issued by the fire marshal has been violated, he shall with reasonable promptness issue a citation to the responsible person. Each citation shall be in writing and shall describe with particularity the nature of the violation, including a reference to the provision of the state fire code or order alleged to have been violated. In addition, the citation shall fix a reasonable time for the abatement of the violation. When the citation is issued by an officer other than the fire marshal, a copy of the citation shall be furnished to the fire marshal.

(B) The fire marshal may prescribe procedures for the issuance of a notice in lieu of a citation with respect to de minimis violations which have no direct or immediate

relationship to safety or health.

(C) Each citation issued under this section, or a copy or copies thereof, shall be prominently posted by the responsible person, as prescribed in the state fire code, at or near each place a violation referred to in the citation occurs.

With the Ohio Fire Code in effect throughout the state, why would a community want to adopt a local fire (i.e., 1984 Basic/National Fire Prevention Code) prevention code persuant to the laws mentioned in the opening paragraph? There are many answers to this question. One, there is local control of local fire safety concerns, including the ability to keep any violation hearing local. Two, there is the ability to adopt current rules which are in concert with the everchanging Ohio Basic Building Code (OBBC- currently based on the 1984 Basic Building Code). Three, there is the ability to adopt current rules which reflect fire safety in the everchanging existing environment. Four, local adoption of fire safety regulation does not affect the authority or use of the OFC. Actually, with local adoption, the inspector has a choice as to which enforcement route he wishes to take; i.e., that state route with OFC on state citation forms or the local route with local regulations (1984 BOCA Basic/National Fire Prevention Code )on local citation forms.

Shouldn't you, as trustees, establish a modern mechanism for your fire safety inspector(s) so that fire safety concerns in your community can be addressed reasonably and with current solutions?

#### LOCAL FIRE SAFETY ENFORCEMENT

Ohio Law section, 505.373 ORC respectively permits a township to adopt local fire prevention regulations.

505.373 Fire prevention code, adoption. The township board of trustees may, by resolution, adopt by incorporation by reference a standard code pertaining to fire, fire hazards and fire prevention, prepared and promulgated by the state, or any department, board, or other agency thereof, or any such code prepared and promulgated by a public or private organization that published a model or standard code.

After the adoption of such a code by the board, a notice clearly identifying the code, stating the purpose of the code, and stating that a complete copy of the code is on file with the township clerk for inspection by the public and also on file in the law library of the county in which the township is located and that the clerk has copies available for distribution to the public at cost, shall be posted by the township clerk in five conspicuous places in the township for thirty days before becoming effective. The notice required by this section shall also be published in a newspaper of general circulation in the township for three consecutive weeks. If the adopting township amends or deletes any provision of the code, the notice shall contain a brief summary of the deletion or amendment.

If the agency that originally promulgated or published the code thereafter amends the code, any township that had adopted the code pursuant to this section may adopt the amendment or change by incorporation by reference in the same manner as provided for adoption of the original code.

505.374 Violation of code. No person shall violate a provision of a standard code or regulation adopted under Section 505.373 of the Revised Code. Each day of continued violation of this section shall constitute a separate offense.

Then why did the State Fire Marshal adopt the Ohio Fire Code (OFC) (based on the 1984 edition of the BOCA Basic/National Fire Prevention Code)? The answer is at least two fold. One, there are a large number of small townships that do not have the activity or growth to warrant local adoption of fire safety regulations. Yet, on occasion, the small community fire safety inspector must have access to rules (OFC) he or she can site, which, inturn, are usually enforced through the state system. Second, the State Fire Marshal inspectors need uniform rules that are in concert with other state agencies with which to address fire hazards throughout Ohio.

Therefore, per the madates of section 3737.82 ORC, the Ohio Fire Code was adopted allowing local inspectors access to the CFC through section 3737.42 ORC.
